1. **BILL NO. 1429- AN ORDINANCE AUTHORIZING THE OPENING OF A NEW BANK ACCOUNT FOR THE CITY OF BEL-RIDGE, MISSOURI AS AND FOR THE RECEIPT OF MONIES IN CONNECTION WITH THE AMERICAN RESCUE PLAN ACT FUNDING TO BE DISTRIBUTED IN 2021.**
2. **BILL NO. 1430 - AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF BEL-RIDGE, MISSOURI BY ADDING TWO NEW SECTIONS TO CHAPTER 385 REGARDING RECREATIONAL EQUIPMENT AND PERSONAL PROPERTY IN THE RIGHTS-OF-WAY.**

4. **BILL NO. 1432 – AN ORDINANCE ADOPTING AND ENACTING A NEW CODE OF ORDINANCES OF THE CITY OF BEL-RIDGE, COUNTY OF ST. LOUIS, STATE OF MISSOURI; ESTABLISHING THE SAME; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN, EXCEPT AS HEREIN EXPRESSLY PROVIDED; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE OR ORDINANCES; PROVIDING PENALTY FOR THE VIOLATION THEREOF;**

AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.
